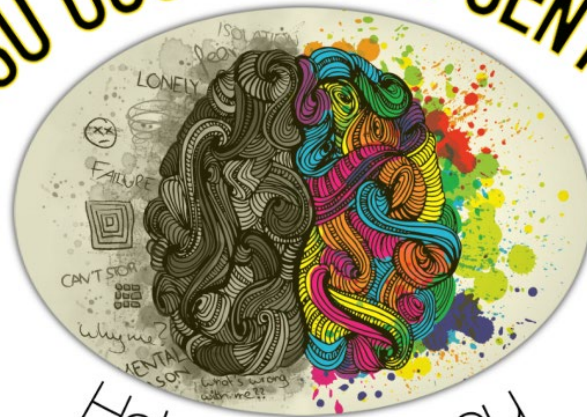

- MEDICAL CARE
- PSYCHIATRIC CARE
- REHABILITATION OF A VICTIM
- WORK LOSS DUE TO A CRIME
- FUNERAL EXPENSES

ELIGIBILITY CRITERIA:

- MUST BE AN INNOCENT VICTIM OF A CRIME WHO HAS SUSTAINED INJURIES OR LOSS
- CLAIM MUST BE FILED WITHIN 1 YEAR OF INCIDENT
- MUST BE A U.S CITIZEN THAT DID NOT CONTRIBUTE TO THE OFFENSE
- CRIME MUST BE REPORTED TO LAW ENFORCEMENT WITHIN 72 HOURS OF THE INCIDENT
- MUST NOT HAVE BEEN CONVICTED OF A FELONY AFTER APPLYING FOR COMPENSATION

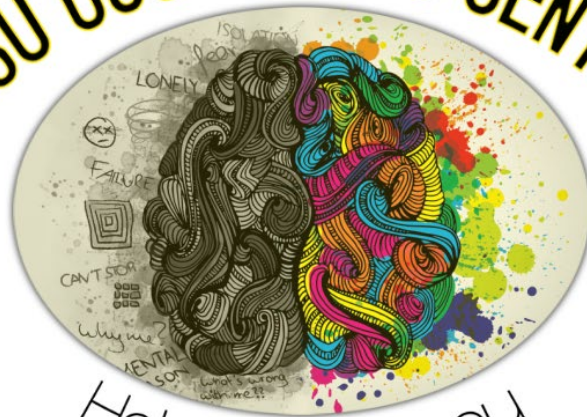

- MUST HAVE SUBSTANTIAL DISABILITIES AND A NEED FOR INCREASED INDEPENDENCE AT HOME (INDEPENDENT LIVING/HOMEBOUND SERVICES)
- MUST HAVE A DISABILITY REQUIRING THE HELP OF ASSISTIVE TECHNOLOGY (STAR AND REHABILITATION ENGINEERING)
