#### Alabama State University History and Tradition

Alabama State University's 157-year history is a legacy of perseverance, progress and promise. The ASU movement began with the impetus to establish a school for Black Alabamians. The Civil War resulted in not only the end of slavery, but also in the opportunity for Blacks to have the right to education. With the Northern victory, Black Southerners, with the assistance of Northern white missionaries and the leaders of African-American churches, set out to establish educational institutions for the freedmen. ASU was born in that movement.

ASU is the global entity it is today because of the fortitude of nine freed slaves from Marion, Ala., who sought to build a school for African Americans previously denied the right to an education. The foresight of these men, now remembered as the "Marion Nine," created what is now known as Alabama State University.

The Marion Nine included Joey P. Pinch, Thomas Speed, Nicholas Dale, James Childs, Thomas Lee, John Freeman, Nathan Levert, David Harris and Alexander H. Curtis. These co-founders and original trustees, with assistance from Marion community members, raised \$500 for land, and on July 18, 1867, filed incorporation papers to establish the Lincoln Normal School at Marion.


The Lincoln School opened its doors on November 13, 1867, with 113 students. In 1873, this predecessor of Alabama State University became the nation's first state-sponsored liberal arts institution for the higher education of Blacks, beginning ASU's rich history as a "Teacher's College."

The Montgomery Alumni Chapter (MAC) of Alabama State University's alumni awarded \$11,400 in scholarships to support 11 students for the 2023-24 school year. The Montgomery County chapter has awarded student scholarships for several years to help students reduce costs as they pursue their education.

MAC President Pamela D. West said the scholarships help level the playing field and ensure financial constraints don't bench talented students.

"Our Scholarships are like the MVP awards of education. They open doors for students, just like a winning touchdown opens up the game for our Hornets," West said. "It's like giving every student a fair shot regardless of their economic background."

Eight students received the *J*ohn Garrick Hardy Scholarship, valued at \$1,200 each, and three students received the Montgomery Alumni Chapter Book Scholarship, totaling \$600 each. Recognized for exemplary academic excellence and good citizenship, the recipients include:

### Coca-Cola Commits \$2 Million for University Advancement



A new partnership between Alabama State University and Montgomery Coca-Cola Bottling Company United can bring more than \$2 million in cash and in-kind gifts to the University.

While \$200,000 in cash was presented to the University for scholarships, new things such as a recycling program, a new workout facility with state-of-the-art equipment, and an 18-wheeler truck for the Mighty Marching Hornets band will be provided over the next five years.


Vice President for Institutional Advancement, Col. (Ret.) Gregory L. Clark, was entrusted by Alabama State University President Quinton T. Ross, Jr., Ed.D., to negotiate a fruitful deal to benefit the students of Alabama State University.

"At the end of the day, we wanted to make sure that we partnered with someone who had student success at the top of their priorities," Clark said. "With this effort, Coca-Cola United came out on top. They really showed a commitment to student success at Alabama State University, and that's someone we want to be married to in this partnership."

This is not the first deal between Alabama State University and Coca-Cola United. Coca-Cola has served as Alabama State University's vending partner for the past 10 years, as evidenced by the dozens of Coca-Cola vending machines placed in almost every building.

In the previous deal with the University, Coca-Cola donated \$100,000. The new contract has a balanced focus on both carbonated drinks and bottled water due to a change in the beverages consumed by the student population. According to Clark, the new campus developments have already begun. The 18-wheeler truck is expected to make its debut in the next few weeks, while remodeling on the new workout facility is in the works. Dual enrollment scholarships will also be awarded to students who are struggling financially.

Clark's goal is that Alabama State University will be able to negotiate a higher amount of money to be used in flourishing student success.



# **First-Generation Students** to Benefit from Alumnus' \$155K Planned Gift

A \$155,000-plus planned gift from Dr. Wislene Guiney ('97), a new member of Alabama State University's Marion Society, will provide first-generation students access to education for years to come.

"I am a first-generation high school and college graduate, and a daughter of a Haitian immigrant. Alabama State definitely changed the trajectory of my life and my family's life. When I thought about my estate planning, I knew I wanted to include Alabama State University to establish a legacy for future first- generation students like me," said Guiney, a certified School Improvement Specialist in Atlanta.

The \$2,500 needs-based scholarship will be awarded annually to two first-generation college students (one male and one female) earning a 2.8 GPA or higher.

"I hope this scholarship will afford young men and women the opportunity to break barriers and generational curses with their families. I hope the recipients of this scholarship will strive for excellence to achieve their educational and career goals. When they reach the point of graduating from ASU and becoming a contributing member of society, I hope they never forget ASU, that they will reach back to help other students," Guiney said.

#### **ASU LOVE**

The 1997 graduate in Special Education credits her education from ASU for much of her success. Guiney has a long history in academics: she was a principal in the DeKalb County School District for 3 years, worked in the Atlanta Public Schools for 10 years, a school administrator in Atlanta for 5 years, and an instructional mentor for K-12 for 5 years in the Greater Atlanta area. She has received several awards and honors for her work in the educational realm.

Guiney encourages alumni and friends who are thinking about the legacy they want to leave behind to give to O' Mother Dear through estate planning.

"There should not be any amount too small to give. What you give could impact the lives of one, two, or a hundred students or more. So, giving back is a way to continue the legacy and to honor our ancestors," she said.

## ASU Awarded \$200K by Alabama Power Foundation to Support Community Workforce Development

## Hyundai presents \$50,000 to ASU during Genesis GV70 Launch

Hyundai Motor Manufacturing Alabama (HMMA) presented Alabama State University with a check for \$50,000 in conjunction with the company's celebration of the start of production of its electrified Genesis GV70 in Montgomery. During a special presentation held at the Hyundai site, Brandon Ramirez, director of Corporate Responsibility and External Relations for Genesis, presented the check to support STEM scholarships as part of its "Genesis Gives" initiative, which supports STEM education and sports programming.

The university was acknowledged for its positive partnership with Hyundai and for its two-day COVID-19 vaccination clinic where the university's Health Services team inoculated more than 1,000 HMMA employees with the COVID-19 vaccine, under the leadership of Davis.

"This is a great day for Alabama State University," Clark said. "On behalf of President Quinton T. Ross, Jr. and the board of trustees, we would like to thank you for what you do to support Alabama State and for being a partner with the university. These dollars will immediately go to help our new engineering program. So, in a couple of years, we will be able to send you interns [to HMMA] and in about four years, we will send some graduates to Hyundai to keep these young men and women in the state of Alabama working. ## Golden Class of 1973 Raises the Bar with \$250K+ Gift

Alabama State University's Golden Class of 1973 marked its 50th anniversary on May 4, 2023, with a reunion celebration on campus and the announcement of a historic \$253,000 gift for scholarship support and university strategic initiatives. The donation, which is the largest gift from a Golden Class in recent history, was presented during the Spring 2023 Commencement Reunion Brunch in the J. Garrick Hardy Student Center Ballroom.

"Our class wanted to raise the bar so people coming behind us will have something to work toward. This is only a down payment. The final check will be written in November when the Class of 1973 brings that amount to \$300,000. This gift is the Class of 1973's way of helping O' Mother Dear invest in the next generation of scholars," said the Honorable Johnny Hardwick, Montgomery County Circuit Judge and Co-Chair of the 1973 Golden Anniversary. "We love our alma mater."

President Quinton T. Ross, Jr. said the Golden Class of 1973 has shown their love and loyalty for their alma mater in so many ways, including by their generous support for scholarships and many other programs that enhance the ASU experience for students.

"The generations of alumni who walked our halls and studied in our classrooms when a lot of us had yet to start our higher education journey are the foundation of our culture. Thank you all for your continued support and laying that strong foundation that we continue to build upon today," Ross said.

"This means a lot to ASU, for alumni to see the value of giving back...It's paying it forward to allow our students to experience the same education of a lifetime that our Golden Class has experienced. I think their excitement and energy are an inspiration to those who want to see Alabama State University's legacy grow."

Michael Washington, Chairman of Finance for the Class of 1973 and the owner of Division 12 Consultants, issued a challenge to the Class of 1974 and every following Golden Class.

"We are going to reset the \$300,000 we hope to give later this year. So, I charge you to do better than our Class in giving back to an institution that has given you so much. We want to keep the bar high. With the vision that Dr. Ross has for this institution, he needs support not only from our class but the entire community as well. If we want the best and to remain a first-class institution, we have to support that with finances and with encouragement," said Washington whose sister, brother and daughter are also ASU graduates.

The Golden Class Reunion/Brunch is an annual event honoring alumni who return to celebrate their 50-year class reunion and walk across the graduation stage for the second time to be honored as being members of ASU's Golden Class.
